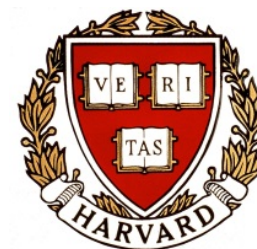

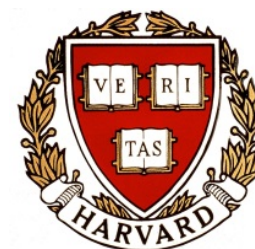

Additional comments:

In June of 2015, health monitoring switched to environmental monitoring from sentinel monitoring and some frequencies for agent testing were changed. Historical results are presented until they expire. Enzootically present in the colony: *H. bilis*, *H. ganmani*, *H. hepaticus*, *H. mastomyrinus*, *H. typhlonius*. *Two rooms in this pod have tested positive for *Spironucleus muris* by PCR, but not by sentinels. (Room 1409 and 1410.) Rooms 1409 and 1410 were consolidated in June 2015. In October of 2015, only room 1409 had *Spironucleus* positives.
