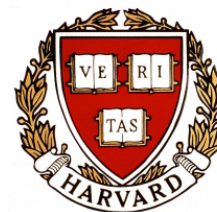

Helicobacter spp. enzootically present in the colony: *H. bilis*, *H. ganmani*, *H. hepaticus*, *H. mastomyrinus*, *H. typhlonius*. *Spironucleus* found via PCR in 1604. Regular testing for this area now includes MuCPV and *Lawsonia intracellularis*. Intermittent positive MuCPV findings in 1604 are investigated and a test and cull program is underway.
